These Terms and Conditions apply to all solicitations, request for proposal, proposals, and orders which have U.S. Government end use (herein referred to as "Contract" or "Contracts") with Arrow Electronics, Inc. its subsidiaries, or affiliates (collectively "Arrow"). When Arrow is the Customer, these Arrow Government Terms and Conditions shall take precedence over the Arrow Purchase Order Terms and Conditions if a conflict exists between the two documents. When Arrow is the Supplier, these Arrow Government Terms and Conditions shall take precedence over the Arrow Terms and Conditions of Sale if a conflict exists between the two documents.

The Parties agree as follows:

1 Quality Statement

Products are tested and packaged in accordance with commercially acceptable practices as outlined in the Product drawing, specifications, and supporting documentation. Requests for modifications or additional quality requirements to standard testing or packaging of Products are rejected, unless called out as a separate, funded Contract Line-Item Number (CLIN).

2 Commerciality Assertion

All goods and services are Commercial Products and Commercial Services as defined under FAR 2.101. Any terms which are inconsistent with the acquisition of Commercial Products and Commercial Services are hereby rejected and not applicable, which include clauses requiring the disclosure of Certified Cost or Pricing Data (CoPD) or the requirements of a Cost Accounting System (CAS) and other Business System requirements.

3 Incorporation of Clauses

The clauses referenced below are incorporated herein by reference, with the same force and effect as if they were given in full text, and are applicable, including any notes following the clause citation to this Contract. If the date or substance of any of the clauses listed below is different from the date or substance of the clause incorporated by the Prime Contract, the date or substance of the Prime Contract applies. The following substitution to the below clauses will apply: (1) for Contracts where Arrow is the Supplier, "Government" will refer to the Customer and "Contractor" will refer to Arrow and (2) for Contracts where Arrow is the Customer, "Government" will refer to Arrow, and "Contractor" will refer to the Supplier.

If the Parties agree to a Time and Material Contract for a Commercial Service, the clause at FAR 52.232-7 Payments under Time and Materials and Labor Hour Contracts will apply and any Order must clearly state that the work is to be performed as Time and Material, not Firm Fixed Price.
